Mayor Shearer reported that he had met with Hamilton Township on Mounds Rd. and the Village has approximately 500 feet of road repair/paving to do. He said Warren County would be replacing the culvert and that the ditches would need to be cleared as well. The Village's monitary responsibility would be around \$12k but Warren County would be proposing and estimate in the near future regarding this project. He mentioned the ADA restroom project meeting had occurred last Friday, he said it was a very professional meeting and that the contractor would begin work next week.

COMMITTEE

Mr. Gaebel said the Easter Egg event would be on April 20th at 10:00 a.m.

Mr. Kembel said the WCML meeting would be at Shaker Run on April 17th.

COUNCIL - No comments from Council

Fiscal Officer Sharee' Dick continues to advise Council that the General Fund balance is still under the desired amount (3 months operating expenses) at \$66,913 after encumbrances of \$21,237. She advised that she would like to see that balance up near \$150,000 to \$200,000 range. The overall fund balances remain in good condition. She continues to advise no major projects until the GF balance was shored up, which will hopefully occur late March through April. Receipts for March (all funds) were \$40,233 and all funds with expenditures of \$46,494. Council reviewed the financial reports, and payroll reports for March month to date and signed the Council review signature page.

Council discussed the 2019 contribution to the Warren County Drug Task Force. Motion to contribute \$1,500 (the same as last year) was made by Mr. Kembel seconded by Mr. Gaebel. Roll call vote was unanimous in favor.

Council discussed Police Training for Officers Arnoff and Brown. Mrs. Humphries seconded by Mr. Gaebel made motion to approve the police training. Roll call vote was unanimous in favor.

Council discussed waiving the building permit fee for the ADA restroom project. Mr. Drook seconded by Mr. Kembel made motion to waive the permit fee. Roll call vote to waive the fee was unanimous in favor.

Motion to adjourn into executive session to discuss personnel issues 121.G1was made by Mr. Gaebel seconded by Mr. Drook. Roll call vote to adjourn was unanimous in favor. Council adjourned into executive session at 7:30 p.m.

Motion to reconvene the regular meeting was made by Mr. Drook seconded by Mr. Kembel. Roll call vote to reconvene was unanimous in favor. Council reconvened at 7:49 p.m.

Resolution No. 2019-07 Increasing Residential Trash and Recycling Rates effective May 1, 2019 and declaring an emergency was read in title only by the Clerk. This legislation comes as a recommendation from the Finance Committee. Motion to adopt Resolution 2019-07 was made by Mr. Kembel seconded by Mr. Gaebel. Roll call vote to adopt was unanimous in favor.

Motion to adjourn into executive session to discuss personnel and legal issues (121.22 G1 & G3) was made by Mr. Kembel seconded by Mr. Gaebel. Roll call vote to adjourn was unanimous in favor. Council adjourned into executive session at 7:37 p.m.
